

Commodity Levy Requirements

for Vegetable Growers

Below is a summary table outlining the current vegetable levies for vegetable growers in New Zealand.

Commercial vegetable growers are required to pay a commodity levy to Horticulture New Zealand regardless of what vegetable(s) are grown. This is used for industry wide activities toward maintenance and development of the New Zealand horticulture industry.

An additional levy is required to be paid to the associated product group for each vegetable crop. Theses levy funds are used to conduct crop specific activities. Please note, levies are fixed for the financial year upon a vote at each product groups AGM.

Worked Example

A grower growing potatoes, carrots and onions are required to pay levies to Horticulture NZ, Potatoes NZ, Vegetables NZ and Onions NZ separately. See below (table 2).
